- 2. Alabama Church of God will NOT provide the following, unless otherwise stipulated:
 - a) Insurance for medical liability of the individuals using the facility.
 - b) Lifeguards for both men and women, if pool is rented.
 - c) Food, personnel or other unless agreed upon in writing before the date of rental.

3. **Renters must provide the following:**

a) A non-refundable deposit of \$500.00 or one-half of total rental amount, whichever is greater, to secure rental dates. This should be submitted 30 days in advance of arrival date and will be applied to balance due.
