**RENTAL ADDENDUM  
CAMP UTOPIA FACILITIES**

1. The Church of God assumes NO responsibility for accidents, injuries or incidents which require medical attention or otherwise.
2. Alabama Church of God will NOT provide the following, unless otherwise stipulated:
  - a) Insurance for medical liability of the individuals using the facility.
  - b) Lifeguards for both men and women, if pool is rented.
  - c) Food, personnel or other unless agreed upon in writing before the date of rental.
3. **Renters must provide the following:**
  - a) A non-refundable deposit of \$500.00 or one-half of total rental amount, whichever is greater, to secure rental dates. This should be submitted 30 days in advance of arrival date and will be applied to balance due. The balance due as well as the cleaning deposit should also be submitted prior to arrival: All checks should be made payable to:

  - b) Certificate of insurance with all attachable or applicable riders showing proof of both medical and liability coverage.
  - c) Lifeguard(s) name and copy of certification certificate issued by the American Red Cross or an alternate certification program recognized by the state of Alabama.
4. **The Church of God commits to providing clean facilities and the renter agrees to leave the grounds in the same condition as was present at the time of rental occupancy. It is understood that the additional \$200.00 cleaning deposit will be returned in not more than 15 working days after the event provided grounds are left in satisfactory condition. \_\_\_\_\_ Group Representative's Initials**
